Mr. Aezaz Ahmad Khan Joiya, Chief Executive Officer, District Education Authority, Multan presided over and addressed the meeting. The chair briefed the participants regarding the Policy of Enrolment & Retention campaign-2017 issued by the Govt. of the Punjab and directed to ensure the implementation of the directions in letter and spirit.

The chair described that the Government has decided to achieve 100% enrolment of out of school children (5 to 9 years old) and 100% retention of enrolled students. In this regard the Chief Minister Punjab has been pleased to desire to achieve 95% enrolment of out of school children by 31.10.2017 under 2018 Goals. Further the Chief Minister Punjab will inaugurate enrolment and retention campaign in first week of April, 2017. The Public Representatives, Deputy Commissioners and CEOs(DEA) will also inaugurate the campaign in their respective districts.

Thereafter, Mr. Muhammad Javed Rafique, DEO(EE-M), Multan briefed that the work on the implementation on the directions issued by the Govt. of the Punjab regarding Enrolment campaign and other issues has already been started in the public and private schools of Elementary wing. Mr. Muhammad Riaz Khan, DEO(SE), Multan intimated regarding the progress of USE campaign and security arrangements made in Higher and High schools of District Multan. He informed that all necessary arrangements as per directions issued by the Govt. of the Punjab have been made in public and private High schools of District Multan. Mrs. Fozia Hina, DEO(EE-W), Multan explained that all necessary arrangements regarding enrolment campaign have already been made in the female Elementary and Primary schools of District Multan.

The chair discussed the following issues / matters and directed to ensure the implementation as per directions in letter and spirit.


